

Terms & Conditions

Zalando GmbH (hereinafter referred to as Zalando), Sonnenburger Str. 73, 10437 Berlin, Germany, registered at the Amtsgericht Berlin (Charlottenburg) under HRB 112394B is hosting a competition called "Party Season Outfit Competition" via the website: www.zalando.co.uk (hereinafter referred to as the "Website"). Both participation and performance of this competition are subject to the following provisions.

By entering the competition, all participants agree to be bound by the following terms and conditions:

§ 1 Registration

Participants are eligible to participate if they register for the competition on the Website and accept the terms and conditions of the competition. For contacting a participant, Zalando will need the participant's name and email address.

§ 2 Competition

1. The competition will run from December 10th 2012 until January 10th 2013.
2. Participation is free of charge and participants are not required to make a purchase to play.
3. Neither making a purchase nor subscribing to the newsletter will increase a participant's chances of winning.
4. For the participation in the competition, participants are required to enter the competition's site on the Website and follow the instructions. Participants will have to compile a party outfit by selecting and submitting specific uniform resource locators ("URLs") of products as offered in the Website's online shop.

§ 3 Participants and Exclusion from Competition

1. Participants must be aged at least 18 years and reside in the United Kingdom. Personal information must be entered correctly and completely. Participants may register only once for the competition.
2. Zalando GmbH employees, Zalando GmbH affiliates' employees and their respective partners and family members may not enter the competition.
3. Not eligible for the participation are also any automated entries via competition robots or any type of competition club. The same applies to any wrong entry made on purpose.
4. Zalando reserves the right to disqualify any participant for breaching these terms and conditions. In this case, the participant in question will not be able to win.
5. Participants using unauthorised or deceptive means to manipulate the system in order to give themselves a competitive edge will also be excluded from the competition. In this case, the winner will see their right to the prize denied which will be reclaimed if necessary.

§ 4 Prizes and Winners

1. Participants can win one Zalando voucher with a value of 400 GBP and five Zalando vouchers with a value of 20 GBP each, which can all be redeemed on the website www.zalando.co.uk.
2. The general terms and conditions of Zalando will be applicable for the redemption of Zalando vouchers.
3. The winners of the competition will be drawn on 11th January 2013 based on a selection of the best party outfit compilations. The winners will be notified via email within 7 days

of being selected and informed of the prize and redemption conditions by Zalando. The prizes will be sent by Zalando via email within 7 days after the winner has been drawn.

4. Any participant's entitlement to a prize will become invalid in the event the distribution of a prize is impossible because either the notification of the respective winner or the delivery of the prize to the respective winner fails and cannot be successfully repeated within 1 month after selection of the winner. If a winner is requested to reply and does not do so within 4 weeks after being notified about their prize, their entitlement to the prize will become invalid and a new winner will be selected. The participants are responsible for submitting correct contact details.
5. The implementation and the selection of prizes remain at Zalando's discretion. In the event a prize is not available due to reasons not caused by wilful conduct or by gross negligence of Zalando, its legal representatives or its agents, Zalando will use its reasonable endeavours to procure an equivalent prize. Any claims regarding such prize replacement are excluded.
6. Prizes may be redeemed by the winner only and may not be transferred to another person. A cash equivalent is not possible. Vouchers cannot be combined with other vouchers or discounts and can only be redeemed once. Rejecting the prize or the terms and conditions will result in the prize being withheld.

§ 5 Premature Closure of Competition

Zalando reserves the right to cancel or close the competition at any time without prior notice. Zalando may especially cancel the competition in the case of technical issues (e.g. computer viruses, manipulation or hard/software errors) or if, due to legal reasons, the competition cannot be properly performed. Should a participant be cause for the cancellation or closure of the competition, Zalando may claim compensation for damages.

§ 6 Data Protection

1. By entering this competition, participants agree that any personal data they provide will be stored in Zalando's records and used for the performance of this competition. Participants agree to supply Zalando with any and all information required for the organisation of the competition.
2. Participants' personal data will only be used for participating in the competition and in accordance with applicable laws. Zalando is entitled to forward personal data to third parties to enable the delivery of the prize. Information is not given to any third parties not involved in the competition's performance or management. The exception to this rule is that, if necessary, information may be disclosed to competent authorities in compliance with statutory obligations.
3. If requested, Zalando will inform participants of the personal data stored by Zalando during the competition and will improve, complete or delete any such at their request. § 7 Liability

1. Zalando shall use its reasonable endeavours in the organisation and management of this competition.
2. Zalando excludes any liability, with exception of the following:
 - a. Liability for damages resulting from injury of life, body or health, caused by wilful intent or negligence of Zalando, of a legal representative or of an agent of Zalando.

- b. Liability for other damages caused by an intentional or grossly negligent breach of duty by Zalando, by a legal representative or by an agent of Zalando.
- c. Liability for damages caused by violation of material contractual obligations which are essential for the performance of the contract and which participants can therefore expect to be complied with, since in case of non-compliance with these, the performance of the entire contract would be jeopardized. In such cases, the liability is limited to direct, typical and foreseeable damages.

§ 8 Promotion on Facebook

This competition is not run, supported, organised nor controlled by the website www.facebook.com ("Facebook"). Zalando remains the sole organiser of this competition and any personal information disclosed will not be made available to Facebook. The Party Season Outfit competition will only be advertised on Facebook, every registration has to be supplied exclusively on the Website.

§ 9 Other

1. Zalando acts in accordance with relevant statutory terms and conditions for competitions.
2. Potential claims regarding redemption of prizes are unenforceable.
